# SANCTIONED PRODUCT THEATER ELIGIBILITY

Companies exhibiting at the FAAIS meeting are required, as a condition of their participation as exhibitors/sponsors, not to schedule any events or dinners until a sanctioned event application is approved by the Executive Director. No other functions, i.e. meeting at dinner, bar, foyer etc. are permitted. Attendees are instructed to attend only FAAIS sanctioned events. Any company found violating this rule will not be able to participate in any future FAAIS annual meetings.

\*\*Dinner Product Theater\*\* - Companies at sponsorship level II (\$30,000) or higher may reserve a spot for our dinner product theater, subject to availability. The sponsoring company is responsible for securing the venue and covering all associated costs, including food, audiovisual equipment, speakers, etc.

\*\*Breakfast Product Theater\*\* - Companies at sponsorship level III (\$45,000) or higher may reserve a spot for our breakfast product theater, subject to availability. FAAIS will arrange the room, audiovisual equipment, and catering for up to 30 attendees. It is the responsibility of the sponsoring company to manage and fund all other event aspects. The provided audiovisual package includes screen, lavalier mic, podium microphone, and technician. Any additional requirements must be covered by your company.

### **DIAMOND Sponsorship Only**

Applications will be accepted starting <u>October 17th</u>. To indicate that you are displaying at the Diamond level, you must submit an exhibit application along with your SPT application. If your company is unable to sponsor at the Diamon level, your SPT time slot will be allocated to the next available company, and your company will be moved to the bottom of the list. If any sanctioned product theaters are available, you will be assigned one of the remaining time slots.

### **RUBY and SAPPHIRE Level Sponsorships**

Applications will be accepted starting <u>October 24th</u>. You must submit an exhibit application along with your SPT application stating your level of sponsorship. If you submit your SPT application prior to October 24th it will not be accepted and will jeopardize your chances of receiving a SPT time slot. Once we receive your application, we will respond via email the following business day. <u>Please note</u>, you MUST sponsor at the Ruby level or higher to receive a breakfast SPT spot.
